DONOR PRIVACY POLICIES

Imagine safeguards donor information to ensure that their privacy is protected and respected. Imagine collects personal data including names, addresses, phone numbers, email addresses and other information Imagine deems necessary to fulfill its mission. This information is collected through event registration, email subscription, online donation services, correspondence, wire transfer, phone, social media, texting and other electronic means. Some data is collected and stored through Blackbaud, which provides Imagine with payment processing and other services. In the event that Imagine is required by law, regulation, judicial or governmental order, discovery request, or similar process (collectively, “Law”) to disclose any personal information, to the extent permitted by Law Imagine shall endeavor to (i) provide donor(s) with written notice of any such request or requirement and (ii) use commercially reasonable efforts to preserve the confidentiality of such personal information In any event Imagine shall only disclose that portion of the personal information which it is advised, in writing, by counsel is required by Law. Except as specified herein, Imagine will not share personal information with any organization without first obtaining your written permission.

PROCESSING ANY ONLINE DONATIONS

When you make an online donation, we will ask you for your name, address, telephone number, email address and credit card information. We will not use the information you give us for any other purpose.

COOKIES

“Cookies” may be used in connection with this site. A cookie is a small amount of identifier data that is sent to your browser from a web server and stored on your computer's hard drive. By using cookies, information is potentially collected without your express knowledge. Most browsers are initially set to accept cookies but permit you to change the setting to refuse cookies or to be alerted when cookies are being sent. While refusal to accept cookies will not prevent the use of some portions of this site, other portions of this site may not function properly without cookies.
